This judicial officer may utilize discretion in determining what constitutes acceptable documentation establishing identity.

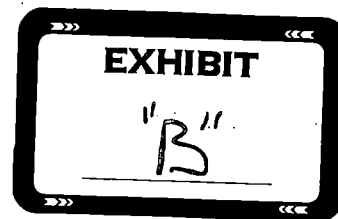
